Cancellation rights

Declarations by the Parents / legal guardians

I/We declare as individuals and jointly that:

- 1 **Terms and conditions:** Before signing this acceptance form I/we have read and understood and I/We agree to the school's *Terms and Conditions* and, where appropriate, the Conditions of Award of a bursary, scholarship or music exhibition, which will undergo reasonable change from time to time. I/We have retained a copy of the school's *Terms and Conditions* with our records.

I/we have also disclosed all court orders or criminal proceedings in relation to my/our child and all court orders, criminal proceedings, statutory demands or bankruptcy petitions relating to either parent (including any court orders relating to financial matters). I/We will disclose any subsequent court orders criminal proceedings, statutory demands or bankruptcy petitions to the school.
- 5 **Parental responsibility:** I/We both have parental responsibility (i.e. legal responsibility) for the child named above. I/We confirm that no other person's consent is required for the child to attend the school.
