

## 2025 Post-results services - deadlines and fees

### Post results services available

#### Access to Scripts (ATS)

Copy of marked examination script to support reviews of marking - not guaranteed before the review deadline.

#### Service 1 (Clerical re-check)

This service will include the following checks: that all parts of the script have been marked; the totalling of all marks; the recording of all marks. Includes a copy of reviewed script - except Eduqas.

#### Service 2 (Review of marking)

This is a post-results review of the original marking to ensure that the mark scheme has been applied correctly. Reviewers will not re-mark the script, they will only act to correct any errors identified in the original marking. Includes the clerical re-checks detailed in Service 1. Includes a copy of reviewed script - except Eduqas.

#### Priority Service 2 (Review of marking) - A Level (GCE) only

This is the same as the Service 2 review of marking but is processed faster.

If a subject grade changes following a Review of Results request, you will receive a refund for any components that are submitted together at the same time or are submitted separately, but the linked components are still marked as in progress. This varies slightly for each awarding body.

All refunds will be processed as soon as possible, but post-results services requests will be prioritised.

After the publication of results, late applications for special consideration will only be accepted in the most exceptional circumstances and must be submitted before the deadline for reviews of results.
